Based on the provision stated in the Instruction to Bidders Clause #10 Clarification and Amendment of Bidding Documents which states that, "Bidders who have purchased the Bidding Documents may request for clarification(s) on any part of the Bidding Documents or for an interpretation. That, Supplemental/Bid Bulletins may be issued upon the Procuring Entity's initiative for purposes of clarifying or modifying any provision of the Bidding Documents not later than seven (7) calendar days before the deadline for the submission and receipt of Bids".

Thus, this Bid Bulletin is issued to address queries and clarifications discussed and agreed upon by the members of the Bids and Awards Committee (BAC) and prospective bidders during the Pre-Bid Conference held on May 13, 2024 to wit:

#### I. SECTION 1 - APPROVE BUDGET FOR THE CONTRACT

There is a change in the Approved Budget Cost (ABC) for the contract on Lot 1- "Supply and Delivery of Various Types and Capacities of Kilowatt-hour meters including its accessories for the first semester of operations for the year 2024" due to the omission of one item which is 6,226 pcs., of Seal, ERC. The ABC will now be amended from PhP6,080,160.00 to PhP6,017,900.00, still it will be inclusive of VAT.

#### II. SECTION II – ELIGIBILITY REQUIREMENTS
