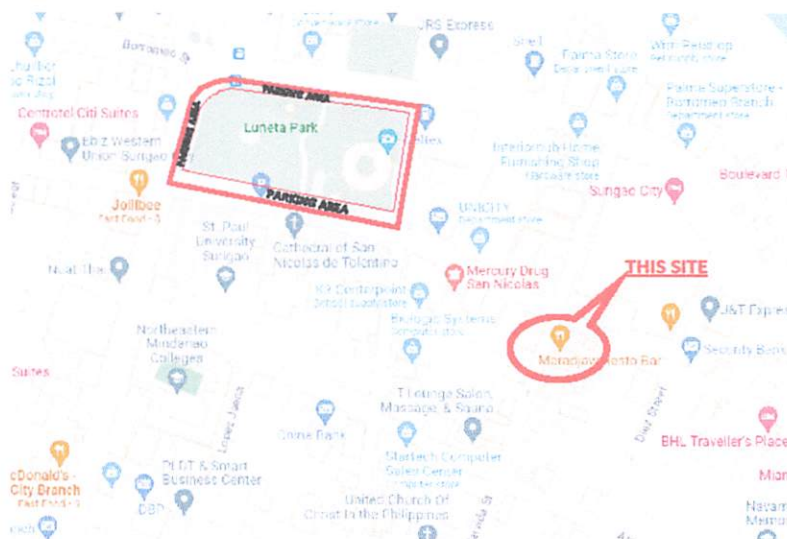
Based on the provision stated in the Instruction to Bidders Clause #10 **Clarification and Amendment of Bidding Documents** which states that, "Bidders who have purchased the Bidding Documents may request for clarification(s) on any part of the Bidding Documents or for an interpretation. That, Supplemental/Bid Bulletins may be issued upon the Procuring Entity's initiative for purposes of clarifying or modifying any provision of the Bidding Documents not later than seven (7) calendar days before the deadline for the submission and receipt of Bids".

Thus, this Bid Bulletin is issued to answer queries and clarifications agreed upon by the members of the Bids and Awards Committee (BAC) and the prospective bidders during the Pre-Bid Conference held last April 24, 2023, to wit:

I. OPENING OF BIDS

1. The Opening of Bids on 09 May 2023, 10:00 o'clock in the morning shall be **"FACE-TO-FACE"**.

II. SECTION II ELIGIBILITY REQUIREMENTS

1. LEGAL DOCUMENTS (FOLDER 1, ENVELOPE 1)

- a. Statement that the bidder is not "blacklisted" or banned from bidding by the government or any of its agencies, offices, corporation or LGUs, and other private corporations or electric cooperatives; including non-inclusion in the Consolidated Blacklisting Report issued by the Government Procurement Policy Board (GPPB), as provided in Section 69.4 of the IRR-A No. 9184.

REMINDER: DO NOT FORGET THE REVISED OMNIBUS SWORN STATEMENT TO BE INCLUDED UNDER LEGAL DOCUMENTS FOLDER 1, ENVELOPE 1. NON-INCLUSION SHALL MEAN NON-COMPLIANT THAT IS TANTAMOUNT TO DISQUALIFICATION.

- b. Subsection 6.2 (j) - The authorized representative shall bring an authorization letter during the Opening of Bids. Each Bidder will only be allowed to authorize a maximum of two (2) representatives to attend the face-to-face bidding. [Emphasis Ours]

- c. Reminding Subsection 13. 1:

13.1 Alternative Bids shall be rejected and considered as failed. For this purpose, alternative bid is an offer made by a Bidder in addition or as a substitute to its original bid which may be included as part of its original bid or submitted separately therewith for purposes of bidding. A bid with options is considered an alternative bid regardless of whether said bid proposal is contained in a single envelope or submitted in two (2) or more separate bid envelopes.

- d. Amending Page 18, subsection 19.6 which will now be read, as follows:

19.6 Each Bidder shall submit four (4) sets of bid documents with Certified True Copy from the Original Remarks, for the first and second components of its bid. The original and the photocopies of the Bid shall be typed or written in indelible ink and shall be signed by the bidder or its duly authorized representative/s.

- e. Amending Page 20, subsection 20, "Deadline of Submission of Bids" which will now be read, as follows:

20 Deadline of Submission of Bids

Last day for the submission of bids ("Hard Copy") will be on or before 9:30 A.M. of May 9, 2023 at Maradjaw Restobar, San Nicolas corner Sarvida Streets, Surigao City, Surigao del Norte.

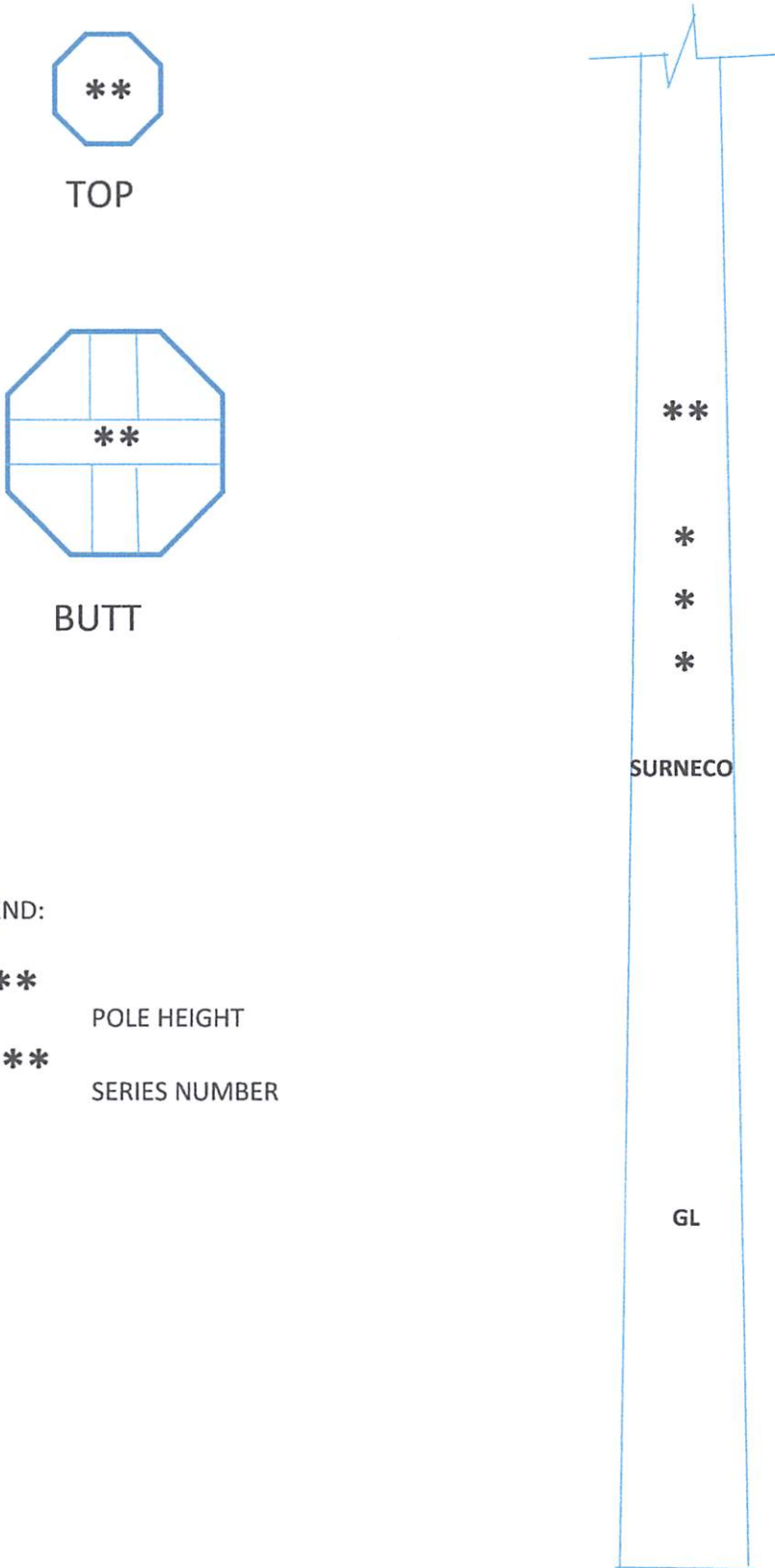
